#### VNS THERAPY® FOR DEPRESSION INDICATIONS FOR USE (US)

The VNS Therapy System is indicated for the adjunctive long-term treatment of chronic or recurrent depression for patients 18 years of age or older who are experiencing a major depressive episode and have not had an adequate response to four or more adequate antidepressant treatments.

In fact, more than 6 in 10 people fail to successfully achieve complete relief from major depression with their first medication.<sup>1</sup>

## > SYMMETRY<sup>®</sup> IS NOT A DRUG, IT USES THE NATURAL PATHWAYS IN YOUR BODY

VNS Therapy® is a device that works by stimulating the vagus nerve



#### What makes SYMMETRY effective:5

- **1.** The vagus nerve is connected to areas of the brain that control mood.
- **2.** SYMMETRY works by regularly sending mild pulses through a thin wire directly to the vagus nerve in the neck.
- **3.** Through these pulses, SYMMETRY has been shown to improve depression symptoms.

#### WARNINGS

All potential risks and adverse events are discussed in the VNS Therapy System physician's manuals. VNS Therapy may not be a cure for depression. Individual results will likely vary. Beneficial results might not become evident for months. Most patients will continue to require antidepressant medications and/or electroconvulsive therapy (ECT) in addition to VNS Therapy. Patients being treated with adjunctive VNS Therapy should be observed closely for clinical worsening and suicidality, especially at the time of VNS Therapy stimulation parameter changes or drug dose changes.

In a 5-year study of 795 patients with depression that is difficult to treat: SYMMETRY + traditional treatment delivered superior reduction in depression symptoms vs traditional treatment alone over 5 years<sup>2</sup>

#### Quality of life (QoL)

#### Sexual function

Using self-reported results, patients' sexual function scores improved each year for 5 years with SYMMETRY + traditional treatment. Scores generally worsened in patients receiving only traditional treatment.<sup>4</sup>

#### WARNINGS (CONT.)

Patients who have pre-existing swallowing, cardiac, or respiratory difficulties (including, but not limited to, obstructive sleep apnea and chronic pulmonary disease) should discuss with their physicians whether VNS Therapy® is appropriate for them, since there is the possibility that stimulation might worsen their condition.

Patients with the VNS Therapy System implanted should have MRI procedures performed only as described in the MRI Chapter of the Physician Manual or in the MRI Guide.

## > INNOVATIVE TREATMENT THAT'S SAFE AND WELL TOLERATED

#### SYMMETRY® is not a drug.4,5,8

It doesn't cause the same side effects as antidepressant medications, such as fatigue, sedation, weight gain, and dry mouth.

It also doesn't cause the same side effects as other medication-free treatments (eg, ECT, TMS), such as memory loss, drowsiness, and poor concentration.

#### Most common side effects with SYMMETRY:<sup>3</sup>

- · Hoarseness or changes in voice
- Prickling or tingling in the skin
- Sore throat
- Increased coughing
- $\cdot$  Shortness of breath

The most commonly reported side effect from the implant procedure is infection.<sup>3</sup>

SYMMETRY is well tolerated and side effects were less noticeable over time.<sup>9,10</sup>

Your doctor can lessen your side effects by adjusting the device settings<sup>3</sup>

ECT = Electroconvulsive therapy TMS = Transcranial magnetic stimulation

#### ADVERSE EVENTS

The most commonly reported side effects from stimulation include hoarseness (voice alteration), paresthesia (prickling feeling in the skin), dyspnea (shortness of breath), sore throat, and increased coughing. Other adverse events reported during clinical studies as statistically significant are ataxia (loss of the ability to coordinate muscular movement); dyspepsia (indigestion); hypesthesia (impaired sense of touch); insomnia (inability to sleep); laryngismus (throat, larynx spasms); nausea; pain; pharyngitis (inflammation of the pharynx, throat); and vomiting. These typically occur only during stimulation, and are well tolerated and noticed less as time goes on. The most commonly reported side effect from the implant procedure is infection.

SYMMETRY is activated by your healthcare professional approximately 2 weeks after the procedure.<sup>3</sup>



Your healthcare professional will monitor your progress and may adjust SYMMETRY over time.<sup>3</sup>

You can continue to use other antidepressant therapies after SYMMETRY is activated: medication, talk therapy, and ECT.<sup>4,11,12</sup>
